Result description: This Result will consist of a document composed of instructions and checklists that will help higher education institutions and public administrations to better define and evaluate urban policies. The guidelines will consider some central themes of urban planning, such as mobility, green areas, open spaces, and by assessing people's needs, risk perception, and quality of life. This kind of analysis will allow selecting the "optimal" scenario for each target area.

#### **Specific tasks:**

- **Preparation of questionnaires** that evaluate the effects of shared projects' scenarios on citizens' health, and help students and other workshop actors to select "the optimal scenarios";
- **Development of the guidelines** on how to illustrate how to use the questionnaires and the checklist.
